The data source is taken from the students of the Public Health 2022 generation, especially A class of UKIM (Moluccas Christian University of Indonesia) Ambon, They performed the highest class average than the other classes of the 2022 generation.

Furthermore, descriptive research qualitative is a research method based on the Philosophy of Post Positivism (Kaelan, 1998; 12) used to examine the object's condition patterns which is natural where the researcher is the key instrument, data

collection techniques performed in a triangulation (combined) data analysis is inductive (qualitative). Qualitative research results emphasize more meaning rather than generalization (Suyono, 2014: 29)

The validation data and analysis of this study is done by Triangulation Technique. The data Triangulation which involves observation, case study, and interview, combines many data-collecting techniques and sources. In this technique, the researcher uses various collecting data techniques to obtain data from the same resources.

Susan Stainback stated that: "the aim is not to determine the truth about social phenomenon, rather the purpose of triangulation is to increase one's understanding of whatever is being investigated. Furthermore, she stresses that what the qualitative researcher is interested in is not the truth per se, but rather the perspectives.

Thus, rather than trying to determine the "truth" of people's perceptions, the purpose of corroboration is to help the researchers to increase their understanding and probability that this finding will be seen as credible or worthy of consideration by others". Through Triangulation "we can build on the strengths of each type of data collection while minimizing the weakness in any single approach" (Suyono 2014: 141).

In this research, the researcher uses Miles and Huberman's model of data analysis which consists of quality data analysis, data collection, data reduction, and conclusion. Data collection means that the researcher collects the data from observation, field notes, and in-depth interviews. All data are collected during the research. Data reduction means the selection of significant data and the trash of rubbish data.

#### RESEARCH FINDINGS AND DISCUSSION

Moreover, the researcher would like to discuss briefly the Effecting Factors of Achievement of A class Public Health 2022 generation. We have these data of the Class Average at the end of the semester. It must be combined with the result of the Group Discussion/Presentation, Mid-term, and Final Test. We add all the result, and

Herewith is the class Average data for English Subjects in the first semester of the 2022 generation. The total classes are four classes of 2022 generation.

According to the Curriculum Standard, there is no point A+ of achievement from all subjects of the teaching-learning process. Because an A+ point shows the prominent point of someone's skill on the subject of the learning-teaching process. This regulation was established 25 years ago as the legal and newest education regulation of the government education department. In other aspects, some 21 students get B- up to B+. It performs a large amount of students. The clarification is that 5 students gave the results point of B+, 11 students attained the point of B, and 5 students gained B-. These are a large number of achievement classes. It proves that many students try harder to achieve the rank of B point achievement. In short, achieving a B point shows their pride or dignity of them. Because proving dignity includes intrinsic motivation for someone to study more and more (Sardiman, 1996: 76).

There are only 10 students who have attained C points (C- up to C+). It shows a small amount of students. The description is that 2 students get a point of C+, 6 students obtain a point of C, and 2 students attain a point of C-. It shows that a small amount of students achieve the rank of C point achievement. Some students are reluctant to attain this point. Because getting a C point is the lowest standard of passing grade in English/other subjects. Some of them are given up to get a higher point than a C point.

They perform no one / zero students obtain D and E points. It means there are no students who fail or no one of the students attains the lowest result point grade in class. There is no one of the students who gets of D and E point. It means every one of them tries harder to pass the grade minimum of points, it is awesome. They show the prestige of very good achievement. It performs rarely happens in every academic year of English teaching-learning.

The Data of Class Average shows that A class is the only highest achievement of class average. The other classes (only the C class) achieve a class average below

65 points. There are two classes (B and D classes) that show the achievement of class average under 60 points.

So, all the data performs the contrast of the other class achievement the class average. The data confirms and states that A class persists in the highest class average achievement. Their strong motivations show by always attending the English class, and almost all the students are diligent to come on time to the class. Motivation is the most important key for the activator to study seriously (Sardiman, 1996: 88) The students or the learners are active, attentive, and enjoying the materials of English class. English subject is delivered at mid-day, but they still show eagerness, activity, and spirit to be involved in the whole process of English class. They never feel or show tiredness and restlessness.

The seriousness of them to do and finishing their group presentation as well as. Each of them tries to be active in their group. They try to prepare all the materials that are related to the title of their group. They arrange the time to discuss with their friends in a group, submit the materials, and edit. Finally one of them must type the materials. It is performed by their group presentation, from the preparation process up to the presentation day. It means all the preparation needs to take more energy and sacrifice to present the best performance of the group presentation.

The eagerness to obtain better points in English subjects, means they prepare the material of English subjects for the Middle Test, absolutely the Final Test at the end of the semester. The result can be examined by comparing the results of their Middle and Final Tests with the other classes. They study in class to get the knowledge and master English basic as their skill, certainly, it makes them easier and faster getting the job in the future. It means the aim of their study is not only to get points but mastering knowledge (Sardiman, 1996: 68)

For the whole semester, the lecturer gives the English lesson according to the syllabus. In this lesson, the lecturer uses English language as the main communication language in the class. Sometimes the lecturer uses a mixed language, which means the Indonesian language is easier for some of them who do not master

English well. When the English teaching materials will be taught according to the syllabus of course it makes the students understand easier, simpler and enjoyable.

The A class consists of the students that pass the entrance test for studying in UKIM (Moluccas Christian University of Indonesia). They start to register and join the entrance test at the first round. It means, they really eager and have full of spirit to be the students of UKIM. Without any reservation, they are really chose and study in UKIM. They never try to register and join the entrance test at the other University in Ambon. They never tempted by any offer from the other University. Their dreams are obvious to be the students of UKIM and later to be the Public Health officer that capable working at the Puskesmas or clinic. Their strong will are clear and persistent. It will never to be changed by any condition.

As matter of fact, all the explanation informs us about the reality dynamic of A classPublic Health 2022 generation as the whole running semester. Finally, the researcher has explained there are ten effecting factors the achievement class average of A class Public Health 2022 generations.

Furthermore, the researcher would like to clarify the other conditions of other classes that support the title of this journal. The descriptions are: The other classes (B,C and D classes) achieve the low of class average. B class achieves 53.35 point, and C class get 62.54 point, the last one is D class attain 59.91 point of class average. Three classes (B,C and D classes) have some students (not more than 4 students) that achieve the lowest point D and E point. It means that the small amount of one class that obtain the lowest of passing grade. As matter of fact, A classes does not perform of D and E point(do not passing grade anymore). They are B and C classes consist of big amount per class. B class 54 people and C class 61 people and D class contains the smallest amount, it is 46 people. The totally amount student of one class are really effected of class average. Becausethe amount of point is divided by the amount of the students. Some students of three classes (B, C and D classes) perform the lazy and neglecting attitude. Some students do not perform the eagerness for getting a better

point of passing grade the achievement English subject. In short, all of this is really effected the result of class average.

Some students of C class were found to drink the alcohol traditional beverages at someone student's house while they are gathering to accomplish the assignment of English presentation group. It is ridiculous. In short, they accept the sanction of their falsething action from the researcher as the English lecturer and from Health Faculty.

The researcher has collected all the data by descriptive case study, in depth interview, field note, and observation. The instruments of research have applied maximum to obtain the data of research. It has well accomplished. These conditions (point 4 and5) have gained from the field note, interview and observation. Especially number 5 point, the data obtain from the leader C class statement and interview, furthermore some students that are coming to do the assignment of English presentation group. So, this evident has more than one an eye witness and the information get from some personal interview.

As matter of fact, the researcher has described Ten Effecting Factors the Achievement Class Average of A class Public Health 2022 generations. There are 5 conditions that quite relevant with this situation after overall must be effected for A class of class average. Anyway, the researcher needs to describe 5 conditions that are really supported ten effecting factors the achievement class average of A class Public Health 2022 generations. These conditions are quite related with the title of this journal. So, two explanations (the conditions and title of this journal) are interrelated, unity, connected one to another. We do not divide them become two parts, but it must be one completely. Between two explanations, we can find the correlations that must effect by one to another.
